PROGRAM POLICIES Sign in & out procedure - we require that guardians sign their child in and out everyday. Failure to comply may result in suspension or termination from the program. Children can not be signed in or out by STAR staff.

Pick up and tardiness – ECO Camp closes at 3:00 p.m. Repeated tardiness may result in cancellation of your child's enrollment. We consider excessive tardiness to be more than 3 times. Late fees are a dollar a minute past 3:00 p.m. You must pay the fine directly to the staff member on duty upon arrival. If you do not pay, your child may not attend the program until that balance is paid in full. If you are late, the STAR staff will make every effort to contact you or one of your emergency contacts. In the event we are unable to make contact by 4:00 p.m. your child will be taken to the local police station. Children are not allowed to be taken home by the staff. **Absences-** because our expenses are fixed, we cannot give credit or make-up days for the absence of your child.

CANCELLATION OF REGISTRATION / SCHEDULE ALTERATIONS This schedule is a contract and cannot be altered. You will be held financially responsible for any weeks missed. STAR requires a two week written notice to cancel your child's enrollment. Your enrollment will remain active until we receive written notification regardless of child's attendance.

REGISTRATION FEE/PAYMENTS/REFUNDS A \$15.00 non-refundable registration fee is due which includes camp T-shirt (If you are also enrolled in STAR Educations Summer camp you need only pay \$10.00 for a T-Shirt). Please attach a check for the registration fee when returning this form. Payments are due the first day your child attends camp for that week. **We encourage weekly payments.** Late payments that are not paid within 5 days are subject to a \$5.00 late fee per week and or the suspension of your child's enrollment until the balance is paid. Bad checks will be handled pursuant to Calif. Civ. Code Sec.1719. Delinquent accounts will be forwarded to Transworld Systems and fined an additional \$20.00. If a refund is required due to advance payment of tuition prior to a two week written notice STAR will give any refund by check less the two week cancellation time.

ECO Camp is a weekly camp and costs \$170 per week regardless of the number of days attended in that week.
